IN CONSIDERATION OF THE EXTENSION OF BROKER PRICING BY IN THE MIX PRODUCTIONS, APPLICANT AGREES TO THE FOLLOWING TERMS:

1. A credit card must be left on file and the balance must be paid in full at the time of pick up via cash or credit card only.
2. As a broker you are responsible for the payment and pick up of any/all orders that you send to In The Mix Productions for printing.
3. The broker is responsible for all files submitted via, email, ftp or disc. If there is a mistake on the file that was submitted the broker is responsible for all printing costs.
4. In the event of default in payment, if the account is placed with an attorney or collection agency, broker agrees to pay all the expenses and costs of collection.
5. If approved, all prices are for you only and can not be used by some one else.

PERSONAL GUARANTY

As an inducement for In The Mix Productions ("Creditor") to extend credit to the _____ hereof, and also in consideration therefore, the undersigned, hereby guaranty to the Creditor, absolutely and unconditionally, jointly and severally, the prompt payment of any indebtedness of the Applicant when due, without regard for the validity, regularity or enforceability thereof as to the Applicant.

The Guarantors agree to pay any finance charges which may accrue on the account of the Applicant and to reimburse the Creditor for all expenses (including costs of collection inclusive of reasonable attorneys fees and disbursements) incurred by the Creditor in connection with any indebtedness of the Applicant, the collection thereof, or the enforcement of this Personal Guaranty. The Guarantors waive notice of acceptance of this Personal Guaranty, the extensions of credit to the Applicant, demand for payment of the indebtedness of the Applicant, notice of default in payment by the Applicant, all other notices to which the Guarantors might otherwise be entitled, and any demand for payment under this Personal Guaranty.

This is a guaranty of payment and not of collection and the Guarantors further waive any right to require that action be brought against the Applicant or any other person. The Creditor shall have the right to discharge or release any one or more Guarantor from any obligation hereunder, in whole or in part, without in any way releasing, impairing or effecting their rights against any other the Guarantors.

No delay of failure on the part of the Creditor in exercising any rights hereunder shall operate as a waiver of the obligation of the Guarantors. No modification or waiver of the obligation of the Guarantors shall be effective unless in writing signed by an authorized officer of the Creditor. Any subsequent incorporation, merger, reorganization or sale of the Applicant's business shall not operate as to terminate this Guaranty which, together with the transactions incident thereto shall be governed by the laws of the State of Michigan. Guarantors consent to the jurisdiction of the Court of the State of Michigan, or any Federal District Court having jurisdiction in such County, for the determination of all disputes arising under Applicant's Credit Agreement and/or this guaranty.
